

EBA 2018 Dove Shoot Rules

September 15th

- Dove Hunt will be held on September 15th from 2:30p.m. until 6:30p.m.
- Hunt is open to current EBA families including staff, students, EBA Alumni and parents and grandparents of those students who have attended EBA in the past.
- Eligible hunters will have from until **September 14th** to call the school or come in and submit their name and phone number for a position. There will be **30** positions for the hunt. Contact/ speak directly to Mrs. Jill Syms, Kindergarten Office Receptionist, at (706) 554-4479. Mrs. Syms' office is located the kindergarten building.
- **Positions for this hunt will be on a first come first serve basis until all 30 positions are filled. Hunters will be told the number of spots left if any, when they register.**
- All hunters with a position must be present in the hunting position the day of the hunt. Positions may not be given to those other than the person it was assigned to.
- Positions will be \$100 each. Payment by check/check-in will be on the day of the hunt by 2:30 pm. Checks will be made out to EBA and given to Hunt Master (TBD) who will be in charge of the hunt. Please Memo on the check "EBA Dove Hunt".
- A random drawing the day of the hunt will choose the position number to be taken by each hunter.
- All those required to have a hunting license must possess a hunting license to shoot. All game laws are to be followed at all times.
- All hunters under the age of 16 yrs old must be accompanied by an adult in the blind and may not hunt alone. Hunters 16 yrs and older may hunt by themselves.
- A maximum of 4 persons per position/blind, 2 guns maximum per position/blind.
- A maximum of 25 birds per hunting position/blind in total can be taken if there is more than 1 shooter in the position.
- Hunters are welcome to bring personal blinds to set up after the position drawing the day of the hunt and remove after the hunt is over.
- Print off **EBA DOVE HUNT RULES** and **EBA DOVE HUNT RELEASE OF LIABILITY** forms sign and bring with you to the hunt.

EBA Dove Hunt Rules

- All participants or observers must sign a release of liability form before entering the dove field area.
- All guns shall be transported to and from the field unloaded.
- All shooting shall be done from the blind position only. No shooting will be done while out of the blind retrieving downed birds or for any other reason.
- Only one person shooting from the blind at one time if two shooters in a blind.
- **"NO SHOOTING AT LOW BIRDS"**, Shooters will shoot from a 45 degree angle and up only.
- Safe carry and handling of guns shall be observed at all times.
- All game laws will be observed at all times. Dove bag limit is 15 per hunter with a total of 25 birds to one blind position if 2 shooters are in one blind.
